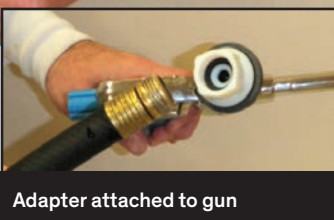
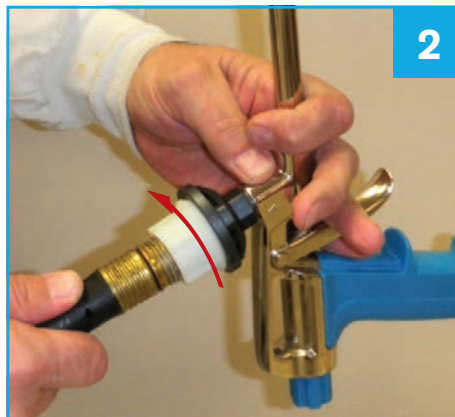
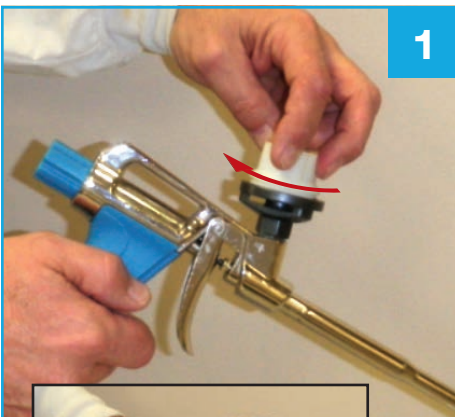
The gun cleanout for GREAT STUFF PRO™ Gasket is the easiest it's ever been. Just use water and a hose.

## Use of gun cleanout tool

- 1 Screw adapter onto gun basket.
- 2 Screw assembly onto garden hose.
- 3 Flush with 4-8 oz of water, until clear. Do not dump into sewers, on the ground or into any body of water.
